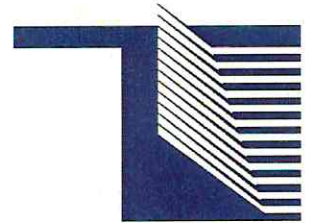

**MEMORANDUM OF UNDERSTANDING AND EXCHANGE OF INFORMATION IN
THE ELECTRONIC COMMUNICATIONS AND POSTAL SERVICES FIELDS**

BETWEEN

**PUBLIC UTILITIES COMMISSION OF LATVIA,
SPRK**

AND

**THE AGENCY FOR ELECTRONIC COMMUNICATIONS AND POSTAL
SERVICES OF MONTENEGRO,
EKIP**

The Public Utilities Commission of Latvia (SPRK) and the Agency for Electronic Communications and Postal Services of Montenegro (EKIP)

hereinafter referred to as "Parties",

DESIRING to create favourable conditions for further promotion of activities and friendly relations between the Parties,

RECOGNISING the importance of growth of electronic communications sector and the influence thereof on the economic development of each country,

TAKING INTO CONSIDERATION significance of effective regulation of electronic communications sector,

BEING CONVINCED that this Memorandum of Understanding may contribute to further development of understanding between Latvia and Montenegro and support with respect to the development of electronic communications sector sign this Memorandum of Understanding in the field of electronic communications and postal services.

PURPOSE of this Memorandum is to facilitate cooperation in the area of electronic communications through support and application of joint measures, exchange of information and experiences in regulation.

Scope of Cooperation

In line with rapid progress in the field of electronic communications and postal services, the following cooperation areas can be determined upon mutual consent of the Parties declaring hereby their intention to implement the following:

- to take all the possible measures to facilitate the development of electronic communications sector in the countries of the Parties;
- to facilitate the development of high quality effective telecommunications services;
- to exchange information on specific strategies and mechanisms of active cooperation within the framework of joint projects in the field of electronic communications regulation;
- to hold the mutual consultations if the Parties deem appropriate;
- to provide appropriate specialists and experts and make the arrangements for joint meetings, seminars, workshops and symposia in the field of electronic communications regulation.

The Parties may continue mutual dialogue in order to create within their spheres of activity, favourable conditions for further development of understanding between both National Regulation Authorities - the Public Utilities Commission (SPRK) and the Agency for Electronic Communications and Postal Services of Montenegro (EKIP).

Good Will

This agreement is a sign of good will of the Parties and is not binding.

Language of the Memorandum

This agreement shall be signed in two identical copies in English and Montenegrin language, and in case of divergences for interpretation, the English text shall prevail.
